*** Urgent documents are evaluated / issued within 2 working days upon receipt before 12:00 Lithuanian time. Incomplete and noncompliant documents will be treated as non-received documents. The fee includes a maximum of 2 working hours. Additional hours are charged at an hourly fee.

Important:

- 1. The operation shall pay 100% of the operation's activity certification fee calculated on the basis of the data submitted by operation. If this fee is not paid, inspection shall not be carried out.
- 2. The working day is equal to 8 hours. Additional hours are charged at an hourly fee.
- 3. Incomplete and noncompliant documents will be treated as non-received documents.
